Description of tasks

Implementation of modifications in the Equipment of the Unit 2600, which are necessary for its safe operation, as derived from the Hazard and Operability Study – HAZOP.

The project included the following briefly described tasks:

- 1. <u>New equipment installation</u> (pumps, exchangers, container), dismantling of the old and alterations in the existing equipment.
- 2. <u>Civil works</u>: Equipment infrastructure foundations, pumps bases, electrical channels works, metal structures fire protection.
- 3. <u>Mechanical works</u>: Metal structures for equipment and piping installation, as well as construction of fuel piping networks for the connection of the old with the new equipment.
- 4. <u>Electrical works</u>: Construction of power networks for the connection of the new equipment with the unit's substation and construction of lighting for the unit's new sections.
- 5. <u>Instruments and automatisms works</u>: Installation, unit instruments assembly, construction of instrument networks up to the control room.
- 6. Thermal insulation of piping and equipment.
- 7. Painting of piping and metal items.

8. <u>Unit maintenance</u>: Unit equipment (vessels, towers, exchangers), equipment maintenance maintenance of old instruments, replacement of old items (valves, etc.)
